2.1 By signing this agreement, the "Talent" irrevocably assigns and grants to ANZ all rights and benefits in the depictions of the Talent and all elements of the Talent's performance in the ANZ Welcome the World advertising, including sounds, together with the rights to use anywhere in the world, any such depictions or elements in any manner and for any purpose by any and all means now known or invented in the future and the Talent irrevocably and unconditionally grants to ANZ all consents and waivers required to ANZ's use of any copyright or other intellectual property in any such depiction or element.

3. THE AGREEMENT:

- 3.1 As a Worldwide Partner of Rugby World Cup 2011, ANZ has a number of responsibilities as a sponsor. To ensure ANZ meets these, the Talent (as part of the Promotion) is required to act in a manner to uphold the good name and reputation of the game of Rugby, the Rugby World Cup Tournament and ANZ. The Talent shall not adversely comment about, or make or issue any statement or announcement that brings or has the potential to bring into disrepute ANZ, the game of Rugby, the IRB, Rugby World Cup Limited, any participating union and/or team member(s), match officials, Tournament staff, anti-doping personnel, judicial officials, commercial stakeholder or their rights, or the Tournament.
- 3.2 The parties agree to keep the contents of this Contract confidential, except as required by law. The Talent agrees not to make any media releases or communications about this Contract, or about ANZ without the prior consent of ANZ.
- 3.3 Student Talent agree to the use of their College Student ID photograph to be made available to the agency, DBB NZ to be reproduced on an identity card worn on a lanyard for the purpose of identifying participants at rehearsals and on the day of filming.
